I still await a response to my letter (Jan 27, 2024), detailing 13 specific points of disagreement with supporting documentation, to Deputy Minister Hall's rationales (Sept 6, 2023). Thank you Ministry of Water, Land & Resource Stewardship (WLRS) for responding to our inquiry of May 12. I am glad that things are beginning to realign with respect to the Skeena Region Conservation Lands Program, some 4 to 5 years post cancellations of the Land Act designated conservation lands. I am confident, under your leadership, that you will successfully revitalized the Skeena Region Conservation Lands Program, but only if there is strong directives from the Deputy Minister's office to Skeena Regional Managers that continue to oppose transfer of authorities to the Wildlife Act.

Acknowledging that processes take time and the fact that we are continuing to see development and resource extraction on some of these conservation lands, we have been asking for no further resource development or Land Act tenure issuance on the cancelled Land Act Conservation Lands occurs as this re-designation process is underway. So far this request has

received no response from either the Deputy Minister's (Lori Halls) office or the Skeena Regional Office. A follow-up discussion would be advantageous to all parties.

As you know, the Conservation Lands Program is under the Ministry of Water, Land & Resource Stewardship (WLRS), not the Ministry of Forests. As such, your suggestion that we take up our concern with respect to commercial timber extraction, with little regard to habitat objectives I might add, within the Wildlife Habitat Management Area (WHMA) conservation lands, is perceived to be punting WLRS's responsibility over to the MOF. These WHMAs, although cancelled from the Land Act without consultation, are still legally established via the yr. 2000 Higher Level Plan that was carried forward under the 2006 Objectives Set by Government. Legally, they still are "nonadministered" conservation lands and remain under the authority of your Ministry. There should be no need to re-negotiate there existence through a long drawn out Forest Landscape Planning process while we see forest stands being logged...this is a typical talk and log scenario.

If you could discuss these outstanding issues with your Regional Management Team colleagues and with the Deputy Minister's office, and get back to us, that would be highly appreciated.
